## **AERONAUTICAL INFORMATION CIRCULAR**

All foreign registered aircraft flying into the Zimbabwean airspace shall apply for landing and overflight permit to the Civil Aviation Authority of Zimbabwe at least six (6) hours prior to flight. Effective 12 April 2022, the following fees shall be payable to the Civil Aviation Authority of Zimbabwe before a flight permit is issued.

1. Foreign private aircraft Flight Permit fees

(i)	Flight Permit Application Fee	\$20
(ii)	Minimum En-route Navigation Fee per flight plan leg	\$20
(iii)	Emergency Permit Application Fee (Less than 2 hours prior to flight)	\$100
